On behalf of myself, my heirs, assigns and next of kin, I waive all claims for damages, injuries and death sustained to me or my property, that I may have against the aforementioned released party to such activity.

By this Waiver, I assume any risk, and take full responsibility and waive any claims of personal injury, death or damage to personal property associated with B & L Fitness Inc. including but not limited to taking aerobics classes or other cardiovascular activities classes at the facility, using the facility and its equipment in any manner, form or fashion, and practicing and/or engaging in weightlifting activities, or other related activities on and off the premises. Use of the facility and its equipment includes but is not limited to mean use of hot tub, sauna, steam room, swimming pool, ice rink, tanning bed, daycare, basketball court, tennis courts, racquetball courts, track, recreational lounge, nautilus, etc.

The provisions of this WAIVER AND RELEASE may be waived, altered, amended or repealed, in whole or in part, only upon the prior written consent of all parties.

The provision of this WAIVER AND RELEASE will continue in full force and effect even after the termination of the activities conducted by, on the premises of, or for the benefit of B & L Fitness Inc., whether by agreement, by operation of law, or otherwise.
